Post-Completion OPT Reporting Requirements (12 Months)

1. All F-1 students who have completed their OPT must report back to the International Center for Education and Career Development (ICECD) within 12 months of the end of their OPT period.

2. Reporting is required for all students, regardless of whether they are currently in the U.S. or abroad.

3. Reporting can be done online through the OPT Reporting System (ORS) or in person at the ICECD.

4. Students who do not report back to ICECD within 12 months of the end of their OPT period may be considered out of status and may be required to leave the U.S.

5. Students who are currently in the U.S. and have not yet completed their OPT should report back to ICECD as soon as possible.

6. Students who are currently abroad and have not yet completed their OPT should report back to ICECD as soon as they return to the U.S.


